

## Nebraska Household Hazardous Waste Collection Events/Facilities

This household hazardous waste (HHW) directory is provided as a service to Nebraskans seeking disposal of outdated, unusable, or unwanted pesticides, and other types of HHW. These facilities likely have differences in the type of HHW they will accept. Most, if not all, DO NOT accept commercial or agricultural pesticides. Users are encouraged to contact these facilities ahead of time to determine these limitations. Individual collection events will be added as they become known.
