Do not apply within one day (24 hours) of harvest for grain and stover and 60 days for forage.

Do not make applications less than 7 days apart.

Do not apply more than 0.1 pound active ingredient per acre per season including At-plant plus foliar applications of Mustang MAXX Insecticide.
